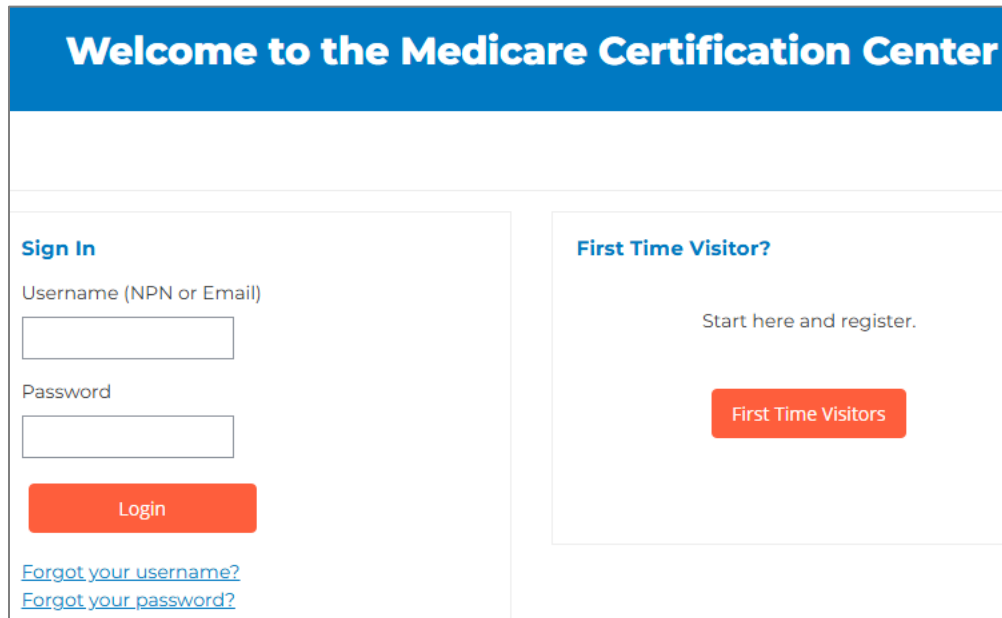

- Certification completed for ALL products, which requires completion of core certification training, ALL compliance training, and ALL product training.
- To receive renewal commissions on existing policies, you must also be certified and maintain an active license and appointment for the upcoming year.
- Failure to complete all required product modules will result in a noncompliant and non-commissionable sale.
- Licensure and appointment paperwork turned in for all states in which you intend to sell.

Important notes:

- If you have completed and passed AHIP + Medicare Fraud, Waste, and Abuse, you must be 100% completed on the Elevance Health site to be certified.
- You must have an active license and appointment to receive a Ready to Sell email within 24-48 hours.
- To ensure you maintain your eligibility to receive renewal commissions, you must maintain a continuous Ready to Sell status by re-certifying every year and keeping on top of your active licenses (without a lapse) and appointments for each state. It is not just a suggestion; it's a CMS requirement.
